

Acceptance of Enrollment Contract 2012 - 2013

***Read the following information. Return the signed and dated information with your non-refundable deposit by July 15, 2012. If we do not receive this deposit, your child's position will be relinquished to someone on our waiting list.**

A full month's tuition payment based on the program for which we have registered has been submitted with this agreement to guarantee my child's place. This tuition payment/deposit is **non-refundable**, regardless of early withdrawal. This payment will be applied to my 9th and final payment of the school year, May 1, 2013.

The yearly tuition amount is divided *equally* into nine (9) monthly payments beginning **SEPTEMBER 1, 2012 – MAY 1, 2013**. Tuition will be collected the first of every month thereafter. No allowances will be made for absences due to illness, disability or vacation.

A \$25.00 late fee will be charged to your account if it is not paid in full by the fifth (5th) of every month. Excessive late fees and an overdue account may lead to the suspension of your child until the account is brought up to date. A \$30.00 fee will also be assessed to your account for any returned checks. Statements are sent only for overdue accounts, extra hours and miscellaneous fees.

If you chose to withdraw your child from Norbeck Montessori after August 15, 2012, notice must be given in writing to the office. Payment will be expected in full and will be based on a prorated monthly amount calculated to end thirty (30) days from receipt of withdrawal notice. Please note: your initial, non-refundable deposit can not be used as a credit toward this amount.

Norbeck Montessori closes at 6:00 p.m. nightly. If you arrive after closing time a late pick up fee of \$15.00/every ten (10) minutes will be paid by you directly to the staff member upon your arrival.

If your child is enrolled in Program A (9:00 a.m. – 12:30 p.m. M-F), Program B (9:00 a.m. – 4:30 p.m. M-F), or Program C (8:00 a.m. – 3:30 p.m. M-F) you will be charged \$10.00 per hour for any additional hours acquired beyond your child's program time schedule.

A special child care program is offered during the winter and spring breaks in order to accommodate working parents. Children enrolled in Program D (7:00 a.m. – 6:00 p.m. M-F) and Program B (9:00 a.m. – 4:30 p.m. M-F) are eligible for this service at no additional cost. This special child care program is available to all others enrolled in our Center at the cost of \$40.00 per day. Spaces are limited and available on a first come – first serve basis. Sign up forms will be distributed to all families prior to each scheduled break.
